Federal Funding

The Association of Assistive Technology Act Programs (ATAP) facilitates the coordination of state AT Programs nationally and provides technical assistance and support to its members as well as strives to protect and increase funding for the AT Act.

ATAP was level-funded for the 56 State and Territory Programs for AT at \$31 million from 2004 to 2015.

In the FY2016 Federal Budget, the AT Act received the first increase of \$1 million.

Over FY2016 to FY2022, the AT Act received increases to bring the total line item to \$36.5 million – A total of \$5.5 million in increases.

These consistent increases are directly related to the advocacy work facilitated by ATAP and provided by the AT Act programs.

The House FY2023 Labor, Health and Human Services Appropriations Bill funded the Assistive Technology Act at \$44 million. It now sits in the Senate for final approval.

This is a great start as the House and Senate begin finalizing the FY2023 budget in the coming weeks.

Leadership

Brett Burden and Page Hudson continue our leadership training with Prevailing Leadership. Our next in-person session is in December in Rapid City. It's truly a great experience and gets us working with BHSSC staff that we normally would just email or talk to on the telephone.

The 2023 Leadership Symposium will once again be virtual and will take place March 28-30 from noon to 3 PM Eastern.

Honeybee Switch

Easterseals Crossroads Indata Project added a HoneyBee Switch to their library. It is a really cool device for people who cannot operate traditional switches and buttons. The HoneyBee Switch is an "innovative, easy-to-use" switch that senses the proximity of a hand, finger, head, foot, etc. To activate the HoneyBee Switch, the user simply places his or her hand, head, or another body part over the sensor window. An audible tone will sound when there's activation.
