Greetings!

Happy New Year, 2023! What a year 2022 was for the Association of Assistive Technology Act Programs (ATAP) and its members! Not only did we receive a \$1 million increase for FY22, but we also squeaked out another \$1.5 million at year's end for FY2023. AND...to top it all off, the Assistive Technology Act was reauthorized and is now officially called the 21st Century Assistive Technology Act! Furthermore, ATAP won the AT Act Technical Assistance grant to serve State and Territory Assistive Technology (AT) Act Grantees. What a year! We must give a big "Thank You" to Audrey Busch-Treussard and her team for their tireless work and dedication to make these things happen, as well as all of you!

These steady funding increases to the AT Act Programs are significant and say a lot about the political climate surrounding assistive technology. These yearly increases indicate that the legislature is beginning to see the personal benefit of AT for people with disabilities and for those who are aging, as well as the ROI of AT. That said, we are only on the ground floor where we need to be to help more people access and acquire AT, but at least we have our foot in the door!

AT History

The Federal Assistive Technology Act started in 1988. It was reauthorized in 1994, again in 1998, again in 2004 and finally reauthorized to the 21st Century Assistive Technology Act at the end of 2022.
