## Technology Solutions for Life's Limitations

## **Greetings!**

Happy Summer! I hope everyone enjoyed their 4<sup>th</sup> of July! I also hope everyone survived the 2 Derechos we encountered in the last couple of months. They really did a number on the east side of the state. Hopefully, we can just have some "normal" storms as we continue through the summer.

A Derecho is a widespread, long-lived, straight-line windstorm that is associated with a fast-moving group of severe thunderstorms known as a mesoscale convective system. Derechos can cause hurricane-force winds, tornadoes, heavy rains, and flash floods.

#### **Federal Funding**

The Association of Assistive Technology Act Programs (ATAP) facilitates the coordination of state AT Programs nationally and provides technical assistance and support to its members as well as strives to protect and increase funding for the AT Act.

ATAP was level-funded for the 56 State and Territory Programs for AT at \$31 million from 2004 to 2015.

In the FY2016 Federal Budget, the AT Act received the first increase of \$1 million.

Over FY2016 to FY2022, the AT Act received increases to bring the total line item to \$36.5 million – A total of \$5.5 million in increases.

These consistent increases are directly related to the advocacy work facilitated by ATAP and provided by the AT Act programs.

The House FY2023 Labor, Health and Human Services Appropriations Bill funded the Assistive Technology Act at \$44 million. It now sits in the Senate for final approval.

This is a great start as the House and Senate begin finalizing the FY2023 budget this summer.

## Leadership

Brett Burden and Page Hudson continue our leadership training with Prevailing Leadership. Our next in-person session is in August at the TIE office in Rapid City. It's truly a great experience and gets us working with BHSSC staff that we normally would just email or talk to on the telephone.

## **DakotaLink Advisory Council**

We have determined that 1-year terms for officers is a little too short to get comfortable in those positions. During the last council meeting, we voted to extend the officer terms to 2 years. This will help to grow the council better as the experience will be 8 meetings instead of just 4.
