A degree in computer related sciences along with experience is required, however, field experience with Low Vision AT may be substituted. #### 2019 Fall Conference in Sioux Falls

#### December

Congress approved a bipartisan final spending package for Fiscal Year (FY) 2020, just a day ahead of a temporary deadline and nearly three months after the fiscal year began. The \$1.4 trillion package includes a previously approved \$49 billion boost to discretionary spending. The big news here for State Assistive Technology Act Programs is a \$1 million increase dedicated only to State Assistive Technology Act Grantees! Therefore, it is guaranteed our program is to receive an increase in FY 2020! The gift giving began early in Washington, and there are no complaints from ATAP!

We are continuing our ATAP Membership calls (Zoom Meetings) striving for reauthorization of the 21<sup>st</sup> Century Assistive Technology Act.
