# **Quarterly Zoom Meeting**

**Meeting Notes** 

March 20<sup>th</sup>, 2025

The DakotaLink Advisory Council meeting on March 20th covered key legislative updates, advocacy efforts, and upcoming activities. The President is expected to sign an executive order affecting the Department of Education, but funding for low-income families and special education remains intact. The grantees requested \$42 million for fiscal year 2026, with \$500,000 allocated to South Dakota. The upcoming Assistive Technology Awareness Day is set for April 30, with a major media blitz planned. The council also recognized the contributions of various agency representatives, including Sandy Neyhart, who is retiring. The next meeting will be held in Sioux Falls and Rapid City on June 25 as well as on Zoom.

#### Welcome and Roll Call

- Page welcomes everyone to the Spring 2025 DakotaLink Advisory Council meeting, mentioning legislative updates, advocacy efforts, and upcoming activities.
- Richard conducts the roll call, confirming the presence of Brett, Burden, Page Hudson, Richard Moeller, Kendra Gottsleben, Morgan Beckman, Kayla Kane, Amy Scepaniak, Mollie Keating, Bill McEntaffer, Beth Schiltz, Konnie Ellis, Tana Zwart and others.
- Morgan Beckman introduces herself as the new quality assurance and support specialist, replacing Jessica Sehnert on the council.
- Richard continues with roll call, confirming the attendance of all present.

## Approval of Previous Minutes and Agenda

- Richard calls for a motion to approve the previous minutes, with Bill moving and Amy seconding.
- The minutes are approved without any changes.
- Richard asks for a motion to approve the draft agenda, with Sandy moving and Konnie seconding.
- The agenda is approved without opposition.

### Legislative Updates and Advocacy Efforts

- Page discusses the President's upcoming executive order to close the Department of Education, ensuring continued support for low-income families, Title One funding, and special education services.
- Page emphasizes the importance of the Assistive Technology Act (AT Act) as a law, not just a grant, and the need for advocacy efforts for additional funding.

- Page shares details from the leadership symposium, focusing on brainstorming and collaboration among program managers to improve the implementation of the AT Act.

#### Assistive Technology Awareness Day and Media Blitz

- Page announces Assistive Technology Awareness Day on April 30, with a major media blitz involving social media, advertising, and highlighting key talent within the DakotaLink Advisory Council.
- Page encourages members to share success stories and impactful stories for the media blitz.
- The importance of showcasing the talent within the council and the agency representatives is emphasized.
- Page mentions the upcoming in-person meeting in Sioux Falls and Rapid City, with options for Zoom participation.

## Funding and Legislative Updates for Fiscal Year 26

- Page discusses the request for \$42 million for fiscal year 26, including \$2 million for program efficiency.
- The funding breakdown for South Dakota is approximately \$500,000.
- DakotaLink's dual role in providing nonprofit AT Act services and fee-for-service activities is explained.
- The importance of the return on investment documentation in presenting the case for increased funding is reiterated.

- Mollie Keating from the Disability Rights Advocate is recognized for her advocacy and direct service to individuals with disabilities.
- Matt Cain, CEO of Independent Living Choices, is recognized for his leadership and contributions to independent living services.
- Beth Schiltz from the Department of Education is recognized for her work in disability services and accessibility.
